

**REGISTRATION REQUIREMENTS
REGISTRATION BY BIRTH (PEDIGREE)**

1. Stallion Reports are required.
2. Any foal born in 1994, or after, must be DNA typed for parentage verification. Sire and dam will also have to be DNA typed. Should the horse(s) have been DNA typed previously, this will be accepted., owner will need to complete a verification of Alias Certificate of Registration form indicating the RHBAA registration name and number. A copy of the DNA results and the verification must be filed with the RHBAA.
3. The horse must be the progeny of a registered Racking Stallion and a registered Racking Mare.
4. Horses to be registered, sired by a registered Racking Stallion, out of a registered Racking Dam, must have on the application for registration, the name and registration number of both the sire and dam. The signature of the owner of the sire (at time of service) is necessary to process the application for registration in INK.
5. Transfers are required with the application for registration of foals when someone other than the owner of the foal owns the dam when the application for registration is submitted. Transfers must be attached to such applications, date of purchase required, and fee paid for both registration and transfer.
6. It is necessary that the RHBAA be notified when a stallion is gelded, and given date of gelding.
7. The name of any registered Racking Horse can be changed, upon payment of fee, provided it has no registered Racking foals.
8. Any person, who shall willfully register or record a false pedigree, shall be barred from making further registrations, the registration of such pedigree shall be canceled.

REGISTRATION BY QUALIFICATION

(Examination)Horses meeting the personally inspected and approved by a qualified commissioner designated by the RHBAA to determine that the horse performs the "track" as defined in the Bylaws. All horses foaled January 1, 1994 or after, must be DNA typed in accordance with the requirements of the RHBAA in order to be qualified for registration.

INSTRUCTIONS

1. This form may be used for:
 - A. Registration of foal with DNA included
 - B. Commission Registration (Must be completed, signed & dated by a licensed RHBAA Commissioner)
2. FEE SCHEDULE: If you wish this to be your free RHBAA membership pedigree registration, put FREE on the fee line.
3. NAME: Provide three (3) name choices in section #3. Names are limited to 25 letters (apostrophe counts as a letter).
4. SEX: In Section #4, indicate the sex of The Racking Horse (Stallion, Mare, Gelding)
5. COLOR: Check only one body color in Section #5. If the Racking Horse is Spotted or Roan, check the appropriate basic color and the Spotted or Roan box.
6. BREEDING INFORMATION: In Section #6, enter the date the mare was serviced by stallion. Enter the date of birth.
7. SCARS, UNSUSUAL MARKS: In Section #7, give written description of any scars or unusual marks.
8. MARKINGS: In Section #8, List the markings on the horse. Face and Leg markings should be included. If there are no markings, put 'none'.
9. SIRE AND DAM: Enter the proper registered names and numbers of both the sire and dam.

10. SIRE & DAM OWNER SIGNATURE:

In Section #10, obtain signatures of mare owner at foaling time and stallion owner at time of service. Transfers are required with the application for registration of foals when someone other than the owner of the foal owns the dam.

11. OWNER INFORMATION: In Section #11, OWNER'S SIGNATURE is REQUIRED. Print name, address and phone Number of the owner. Sole owner must be 18 years of age. *****

12. REGISTRATION BY QUALIFICATION: Persons desiring to qualify a horse by performance, must submit to a licensed Commissioner of the RHBAA. Upon inspection, the Commissioner shall complete Section 13.

PLEASE REVIEW THIS APPLICATION CAREFULLY BEFORE MAILING TO THE RHBAA OFFICE. BE SURE YOU HAVE PROPER DATES, MARKINGS, SIGNATURES ETC.

CERTIFICATES OBTAINED BY FRAUD OR MISREPRESENTATION WILL BE CANCELLED, AND FUTURE CERTIFICATES DENIED THE OFFENDING PARTY.
