### BOOTH RENTAL CONTRACT FOR SPRING CELEBRATION

A booth space is 10x10 single or 10x20 double with electricity furnished  
**Enclosed you will find a contract for the Spring Celebration Vendor Booths at a reduced rate. You may reserve by the day.**

In order to ensure a booth for the Spring Celebration, please return your contract signed and completed in full along with your payment. As always, we would like to please each and every one of you, but with limited spacing we will have to set priority with those who respond with a contract and payment.

Please remember the following:

You are entitled to only one parking pass (Additional passes may be purchased from the RHBAA Office).

The main light in center ring will be turned off after the show, leaving only the booth lights and the house lights on.

All packages delivered to the show grounds for vendors must be picked up at the RHBAA Office during office hours of the show, 8:00am to 4:30pm.

Please go to the RHBAA Office upon arrival where a listing of events, a show program and a parking pass will be available for each vendor. I hope everyone will be joining us again this year. If you have any questions or suggestions, please feel free to contact our office.

Neither the Racking Horse Breeders' Association of America or the Celebration Arena will be responsible for loss or damage caused to horses exhibited or animals, people, vehicles or otherwise brought or sent to the Celebration Arena. The Arena has adopted a leash law. All dogs must be kept on a leash at all times while in the Arena. A smoking designated area has been established at the North and South end of the Arena, prohibiting smoking in other areas of the Arena.

**Blocking a FIRE LANE is absolutely prohibited, and will be enforced.**
