Ronnie Hooker stated that the BOD did vote in guidelines for registering one-sided pedigrees, and he also gave an update on how they are working with other foreign countries to get the breed recognized as a stand-alone breed in those countries.

PROCEDURE FOR REGISTERING HORSE WITH ONE RHBAA PEDIGREED PARENT

The cost will be \$125, the RHBAA unregistered parent horse will be shown on the certificate as "Unregistered Mare" or "Unregistered Stallion". There will be no lineage attached to that side. The RHBAA registered parent will have its lineage attached as shown of record with RHBAA.

The procedure to input a horse of this type into the database will be as follows:

On the registration application, under the parent name in block 9, the Name "Unregistered Mare" or "Unregistered Stallion". will be used when the horse is not RHBAA registered. Everything else will be filled out as usual.

The owner of the horse whose pedigree line is being used must sign and date in block 9 showing they are allowing their horses DNA to be used for a match for the foal.

The RHBAA registration number 180007 will be used for the mare and 180008 will be used for the stallion. The owner number used will be 62919, this will be in the database under RHBAA.
